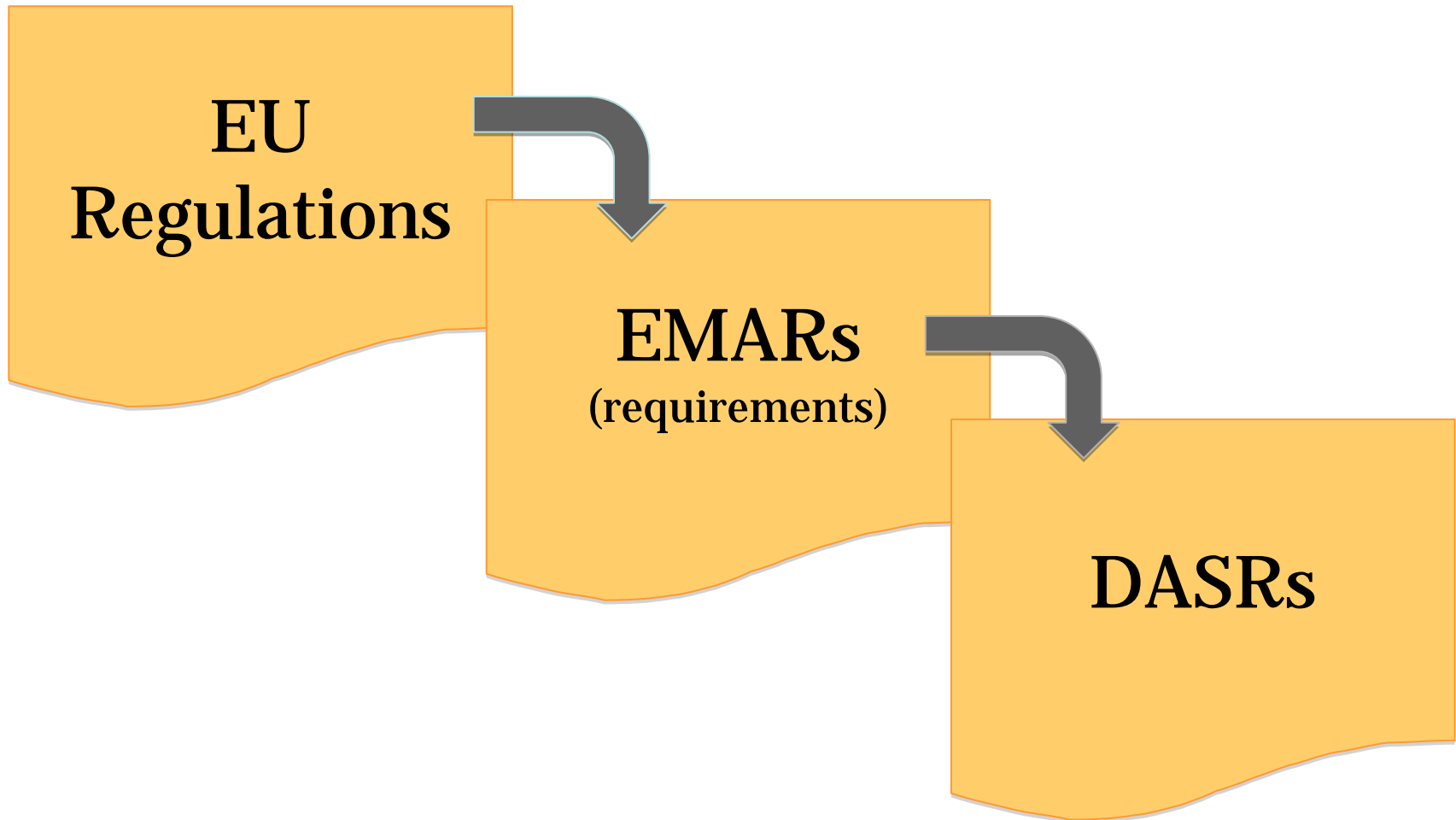


Why am I talking about forms?

- **DASR 21.A.15 – Application**
 - a) An application for a type-certificate or restricted type-certificate shall be made in a form and manner established by the Authority
- **DASR 21.A.163 – Privileges**
 - ... holder of a production organisation approval may:
 - ... Issue authorised release certificates (DASR Form 1) ...

- Authority has established all Manner of Forms
- Forms fall into two categories
 - Please Forms
 - Thank you Forms



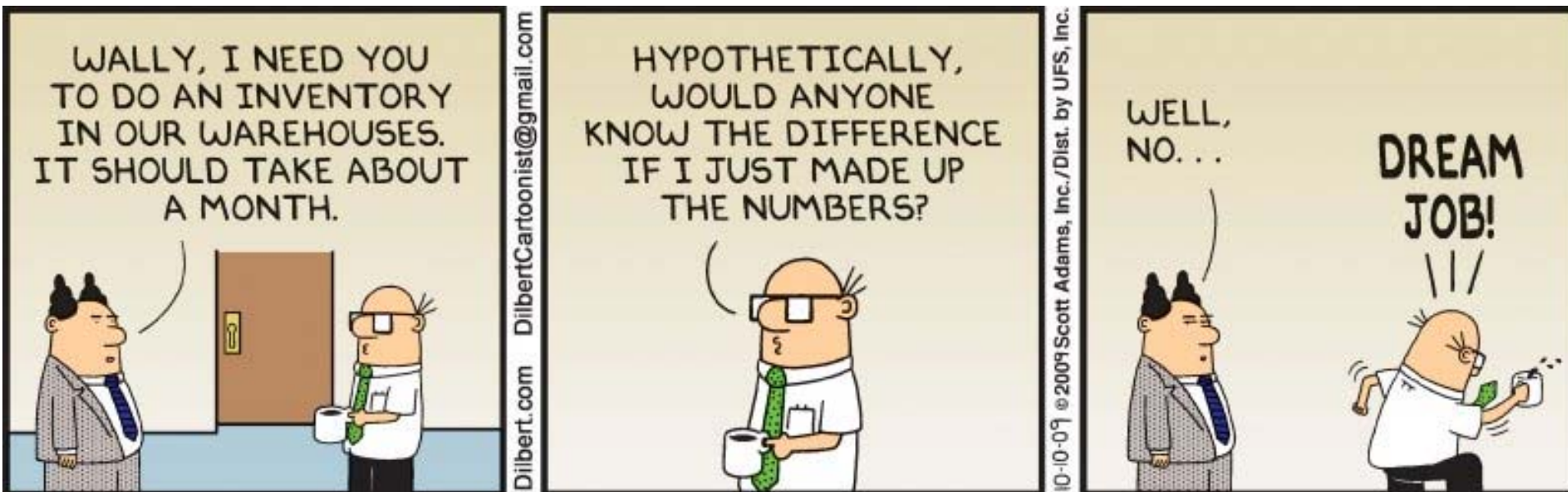
Form Types

- Application to the Authority
- Approval from the Authority (including Certificates)
- Certificates issued by an Approved Organisation
- Currently have 36 DASR forms (unique identifiers)
 - Form 4 has about 10 different uses



Form Numbering

- There's no particular logic or pattern behind Form Numbering



DASR 21 (design)

- **Applications**

- DASR Form 30 Application for Type Certificate Restricted Type Certificate
- DASR Form 31 Application for Approval of Major Change Major Repair Design
- DASR Form 32 Application for Approval of Minor Change Minor Repair Design
- DASR Form 33 Application for Approval of Supplemental Type Certificate
- DASR Form 80 Application for Military Design Organisation Approval
- DASR Form 81 Application for Alternate Procedures to a Design Organisation Approval
- DASR Form 82 Application for Significant Changes to Design Organisation Approval



DASR 21 (design)

- **Certificates/Approvals**
 - DASR Form 18a Flight Conditions For a Military Permit to Fly Approval
 - DASR Form 20a Military Permit to Fly Authority
 - DASR Form 20b Military Permit to Fly Approved Organisation



DASR 21 (Other)

- Applications
 - DASR Form 18b Flight Conditions For a Military Permit to Fly Approval
 - DASR Form 50 Application for Part 21 Production Organisation Approval
 - DASR Form 51 Application for Significant Changes or Variation of Scope DASR 21
 - DASR form 60 Application for Agreement of Production under DASR 21 Subpart F



DASR 21 (Other)

- **Certificates/Approvals**
 - **DASR Form 24 Military Restricted Certificate of Airworthiness**
 - **DASR Form 25 Military Certificate of Airworthiness**
 - **DASR Form 55 Production Organisation Approval Certificate**
 - **DASR Form 65 Letter of Agreement Production Without POA**



DASR 21 (Other)

- Issued under Privilege
 - DASR Form 1 Authorised Release Certificate Part 21
 - DASR Form 52 Statement of Conformity
 - DASR Form 53 Military Certificate of Release to Service
 - DASR Form DDP Declaration of Design and Performance



DASR M (CAMO)

- **Application**
 - **DASR Form 2 Application for DASR M 145 Approval**
 - **DASR Form 15a Military Airworthiness Review Certificate Issue Recommendation**



DASR M (CAMO)

- **Certificates/Approvals**
 - DASR Form 14 CAMO Approval Certificate
 - DASR Form 15b Military Airworthiness Review Certificate



DASR 145 (Maintenance)

- **Application**
 - **DASR Form 2 Application for DASR M 145 Approval**



DASR 145 (Maintenance)

- **Certificates/Approvals**
 - DASR Form 1 Authorised Release Certificate Part 145
 - DASR Form 3 Maintenance Organisation Approval Certificate



‘DRAFT’ DASR Forms

- **All Forms are published with the DASRs. Currently:**
 - They are just rebadged EMAR/EASA forms
 - They are not tailored to any DASR specific requirements (MTCH delegates)
 - Many have an area for payment



Form Equivalence

- **DASR requirement to only fit parts and appliances with an accompanying ‘Form 1’**
 - USN/USAF parts won’t have a ‘Form 1’
 - Authority, through a recognition activity, will determine what is deemed equivalent for a CAMO/145



DASR Form 4

- **Acceptance of Nominated Management Personnel**
 - Applicable across DASR 21/M/145
 - Means by which the individual applies to be the ‘Nominated Person’ in an Approved Organisation
 - Authority accepts those appointments, and the person becomes a ‘Form 4 Holder’

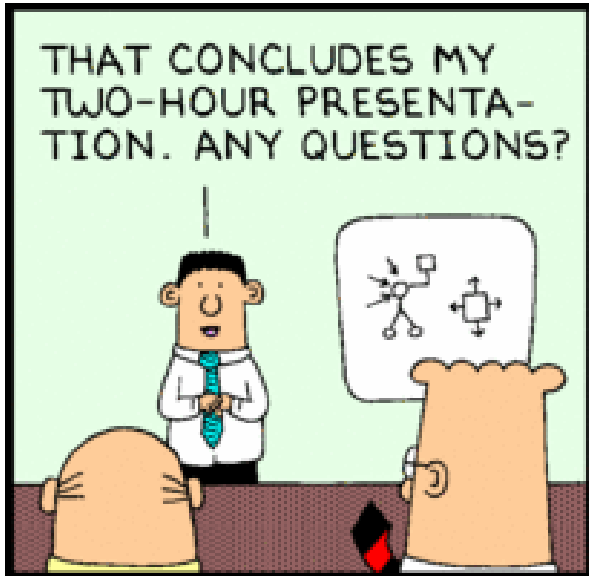


DASR Form 4
