**Citation**

1. This determination may be cited as Overseas Defence Determination 1990/143.

**Commencement**

- 2.1 Sub-clause 4.1 of this determination is to be taken to have commenced on 16 August 1990.
- 2.2 Sub-clause 4.2 of this determination is to be taken to have commenced on 11 October 1990.
- 2.3 Sub-clause 4.3 of this determination is to be taken to have commenced 14 days after the first day of the pay period commencing on or after the date of signature of this determination.

**Principal Determination**

3. In this determination Determination 3733, Overseas Vehicle Contribution, as in force<sup>1</sup> is referred to as the Principal Determination.

**Contribution for full-time use of official vehicle**

4.1 The Schedule to the Principal Determination is amended by omitting item 1 and substituting the corresponding entry in the Schedule to this determination.

4.2 The Schedule to the Principal Determination is amended by omitting items 3 and 7 and substituting the corresponding entries in the Schedule to this determination.

4.3 The Schedule to the Principal Determination is amended by omitting item 4 and substituting the corresponding entry in the Schedule to this determination.

EXPLANATORY MEMORANDUM

**DETERMINATION NO. 143 OF 1990**

Defence Act 1903

This determination amends Determination 3733, Overseas Vehicle Contribution.

The amendments provide for payment of revised rates of contributions by members of the rank of Colonel and below (and the equivalent ranks in the other Services) who have full-time use of an official vehicle at the overseas localities specified in the Schedule.

The revised rates bring the Australian Defence Force contributions at these localities into line with the rates previously determined for Australian Public Service staff serving overseas and have the same dates of effect except in Pakistan, where contributions are increased with prospective effect.

The retrospective application of this determination does not affect the rights of a person (other than the Commonwealth) in a manner prejudicial to that person, nor does it impose any liability on such person.
