Pursuant to section 58H of the Defence Act 1903, the Defence Force Remuneration Tribunal hereby determines as follows:


1. Determination No 6 of 1992, Salaries, being a determination made by the Defence Force Remuneration Tribunal pursuant to Section 58H of the Defence Act 1903, is amended by:

- a. ✓ deleting the rates of "65645" and "67860" specified in Column 4 of Schedule 2 opposite the entry for Lieutenant Colonel and substituting the rates "67826" and "70041" respectively;
- b. ✓ deleting the rates of "76093" and "78353" specified in Column 4 of Schedule 2 opposite the entry for Colonel and substituting the rates "79367" and "81627" respectively;
- c. ✓ deleting the rates of "84358" and "94956" specified in Column 4 of Schedule 4 opposite the entries for Lieutenant Colonel and Colonel and substituting the rates "86539" and "98230" respectively;
- d. ✓ deleting the rate of "65645" specified in Column 2 of Schedule 5 opposite the entry for Chaplain Division 3 and substituting the rate "67826";
- e. ✓ deleting the rate of "67860" specified in Column 2 of Schedule 5 opposite the entries for Chaplains Division 4A and 4B and substituting the rate "70041";
- f. ✓ deleting the rate of "76093" specified in Column 2 of Schedule 5 opposite the entry for Chaplain Division 5 and substituting the rate "79367";
- g. ✓ deleting the daily rates of "152.87" and "158.03" specified in Column 4 of Schedule 9 opposite the entry for Lieutenant Colonel and substituting the daily rates of "157.95" and "163.11" respectively;
- h. ✓ deleting the daily rate of "177.20" specified in Column 4 of Schedule 9 opposite the entry for Colonel and substituting the daily rate of "184.83";
- i. ✓ deleting the daily rates of "196.45" and "221.13" specified in Column 4 of Schedule 10 opposite the entries for Lieutenant Colonel and Colonel and substituting the daily rates of "201.53" and "228.75" respectively;


- j. ✓ deleting the daily rates of "152.87" and "158.03" and "158.03" specified in Column 2 of Schedule 11 opposite the entries of Chaplain Division 3, Chaplain Division 4A and Chaplain Division 4B and substituting the daily rates of "157.95", "163.11" and "163.11" respectively;
- k. ✓ deleting the daily rate of "177.20" specified in Column 2 of Schedule 11 opposite the entry for Chaplain Division 5 and substituting the daily rate of "184.83";
- l. at Column 2 of Schedule 12, delete the annual rates shown against Consultant Colonel (Medical) of the 2nd and 3rd Military Districts, Colonel Medical, 1st Division and Chaplain Division 4B and substituting the rates of "24558", "24558", "24558" and "17510" respectively.
- 2. This Determination shall take effect on and from 1 January 1998.
