ROYAL AUSTRALIAN INFANTRY CORPS

Pursuant to Section 58H of the Defence Act 1903, the Defence Force Remuneration Tribunal, having inquired into the Royal Australian Infantry Employment categories, hereby determines as follows:

1. Determination No 6 of 1992, Salaries, being a determination made by the Defence Force Remuneration Tribunal pursuant to Section 58H of the Defence Act 1903 is amended by:

a. Deleting from Schedule 1, Part B, Pay Group 1:

Patrolman, Grade 1.

b. Deleting from Schedule 1, Part B, Pay Group 2:

Patrolman Grade 2.

c. Deleting from Schedule 1, Part B, Pay Group 3:

Assault Pioneer;
Mortarman;
Patrolman, Grade 3;
Piper, Drummer and Bugler.

d. Inserting into Schedule 1, Part B, Pay Group 1:

Patrolman.

e. Inserting into Schedule 1, Part B, Pay Group 2:

Patrolman, Grade 1.

f. Inserting into Schedule 1, Part B, Pay Group 3:

Rifleman, Grade 2, Specialist;
Patrolman, Grade 2;
Piper, Drummer and Bugler, Grade 1.

g. Inserting into Schedule 1, Part B, Pay Group 4:

Crew Commander, Mechanised;
Rifleman, Grade 3;
Rifleman, Grade 3, Specialised;
Patrol Commander;
Piper, Drummer and Bugler, Grade 2;
Sniper;
Supervisor, Platoon Infantry Operations.


h. Inserting into Schedule 1, Part B, Pay Group 5:

Company Mechanised Sergeant;
Drum Major;
Patrol Master;
Pipe Major;
Sniper Master;
Sniper Supervisor;
Sniper, Team Leader;
Supervisor, Company Operations.


2. This Determination shall take effect on and from 6 February 1997.
