1 Citation

This Determination is Defence Determination 2001/13, Travelling and motor vehicle allowances (Defence Determination 2000/1 – Amendment).

2 Amendment

Defence Determination 2000/1, Conditions of Service, as amended,¹ is amended as set out in this Determination.

3 After clause 3.1.10

insert

3.1.10A Accommodation and meal costs for dependants

- (1) The cost of accommodation for a dependant is taken to be:
 - (a) for a child under 6 — 10% of the amount for the accommodation; and
 - (b) for any other dependant who is the sole or first occupant of a room — the amount for the accommodation; and
 - (c) otherwise — 20% of the amount for the accommodation.
- (2) For subclause (1), the *amount for the accommodation* is the amount payable to a member if the member were entitled to an amount for accommodation under clause 3.1.4 for the period of travel.
- (3) The cost of meals for a dependant is taken to be:
 - (a) for a child under 10 — half the amount for the meals; and
 - (b) otherwise — the amount for the meals.
- (4) For subclause (3), the *amount for the meals* is the amount payable to a member if the member were entitled to an amount for meals under clause 3.1.5 for the period of travel.

4 Paragraph 3.2.7 (1) (d)

substitute

- (d) the amount worked out under clause 3.2.10A for accommodation and meal costs of any dependants.

5 Clause 3.2.11

Omit the clause.

6 Paragraph 3.4.3 (1) (d)

substitute

- (d) the amount worked out under clause 3.1.10A for accommodation and meal costs of any dependants.

EXPLANATORY STATEMENT

Defence Determination 2001/13

This Determination amends Defence Determination 2000/1, Conditions of Service (“the Principal Determination”), made under section 58B of the *Defence Act 1903*, which includes an allowance for accommodation and meal costs for members’ dependents where travelling in certain circumstances, for example during a removal to a new locality.

This Determination relocates the clause that is the authority for that payment, from the Part dealing with motor vehicle allowance (Part 2 of Chapter 3), to the Part dealing with travelling allowance (Part 1 of Chapter 3). Two consequential cross reference changes are also made. As the clause authorises payment of meal and accommodation costs for members’ dependents it is more properly located with travelling allowance, which provides for meal and accommodation costs for ADF members.

The effect of the provision is unchanged.
