**1 Citation**

This Determination is Defence Determination 2001/23, Uniform maintenance and aide-de-camp allowances (Defence Determination 2000/1 – Amendment).

**2 Commencement**

This Determination is to be taken to have commenced on 30 August 2001.

**3 Amendment**

Defence Determination 2000/1, Conditions of Service, as amended,<sup>1</sup> is amended as set out in this Determination.

**4 Clause 12.1.2 (Uniform maintenance allowance)**

*substitute*

The member is entitled to a uniform maintenance allowance at the annual rate of:

- (a) for a member with the rank of Corporal or lower, or a trainee — \$415; and
- (b) for a member with the rank of Sergeant or a higher non-commissioned rank, including a member of that rank to whom clause 2.1.9 applies — \$499; and
- (c) for an officer, including a member who is required to join, and joins, an officers' mess on a permanent basis — \$675.

**5 Subclause 12.3.3 (2) (Reimbursement for aide-de-camp clothing expenses)**

*substitute*

- (2) However, subject to subclause (3), the amount that a member may be reimbursed must not exceed the following amount (the *specified amount*):
  - (a) for a part-time aide-de-camp to the Governor-General or an aide-de-camp to an overseas visiting dignitary — \$2,317; and
  - (b) for any other member to whom this Part applies — \$1,159.

# EXPLANATORY STATEMENT

## Defence Determination 2001/23

This Determination amends Defence Determination 2000/1, Conditions of Service (“the Principal Determination”), made under section 58B of the *Defence Act 1903*, which includes provisions dealing with uniform maintenance and aide-de-camp allowances.

The adjustments made by this Determination are in accordance with the *ADF Enterprise Productivity Arrangement 1999 – 2002*, which requires the rates of uniform maintenance and aide-de-camp allowances to be reviewed in the September quarter each year, in line with changes in the clothing and footwear component of the Consumer Price Index. In the September quarter 2000 this component of the Consumer Price Index decreased, and the allowance rates were not reduced. This year the Consumer Price Index rate has increased again, and the allowances were adjusted in accordance with the two-year Consumer Price Index movement.

Clause 4 of this Determination increases the uniform maintenance allowance rates by between 5.3 and 5.5%. Clause 5 of this Determination increases the amounts of aide-de-camp allowance by 5.4 and 5.5%. The variation in the increases is due to the effect of rounding on the underlying data.

This Determination commences on 30 August 2001, the beginning of the next pay period following its signature.
