This Determination is Defence Determination 2001/25, Deployment allowance – amendment (Defence Determination 2000/1 – Amendment).

## 2 Commencement

This Determination commences on 2 October 2001.

## 3 Amendment

Defence Determination 2000/1, Conditions of Service, as amended,<sup>1</sup> is amended as set out in this Determination.

## 4 Schedule 13 (Deployment allowance – operational areas)

1	United States-led Coalition Force in the Middle East	All that area of land and waters bounded by a line commencing at 68 degrees east longitude, 5 degrees south latitude; from there northerly in a straight line to the intersection of the shore of the Arabian Sea at high water mark and the boundary between India and Pakistan; from there proceeding along the outer national land boundaries of Pakistan, Afghanistan, Iran, Iraq and Jordan (so as to include those States) to the intersection of the shore of the Gulf of Aqaba at high water mark and the boundary between Jordan and Israel; from there following that shore at high water mark westerly to its intersection with the boundary between Israel and Egypt; from there proceeding along the outer national land boundaries of Egypt, Sudan and Kenya (so as to include those States); and from there easterly in a straight line from the intersection of the eastern coast of Africa at high water mark and the boundary between Kenya and Tanzania to the point of commencement

# EXPLANATORY STATEMENT

## Defence Determination 2001/25

This Determination amends Defence Determination 2000/1, Conditions of Service, made under section 58B of the *Defence Act 1903*. Schedule 13 of that Determination lists operational areas for the purpose of entitlement to deployment allowance. Deployment allowance is paid to ADF members who are deployed with a UN mission or similar force, on a warlike or non-warlike deployment.

The effect of this determination is to remove the operational area relating to the United States-led Coalition Force in the Middle East. This operation will cease with effect from the beginning of 2 October 2001 and the related entry in Schedule 13 is therefore redundant from that date.

This Determination commences on 2 October 2001.
