Environmental	<ul style="list-style-type: none"> • Suitable surface to erect tentage. • Availability of area from 1300h 13 Mar-1200h 15 Mar 09.
Resources and Equipment	<ul style="list-style-type: none"> • Teams are to provide their own tentage. • RP's to give induction brief. • ARTC to provide ablutions, power and waste disposal facilities.

Probability / Likelihood

Descriptor	Meaning
Certain	Almost certain or most likely to occur if the mission or task continues
Likely	Likely outcome during mission or task quite likely
Possible	Would be possible to occur during mission or task
Conceivable	Very unusual occurrence, but conceivable

Exposure

Descriptor	Meaning
Continuous	Continuous exposure at all times for extended duration
Frequent	Frequent exposure is likely to occur during the mission or task
Occasional	Occasional (that is, one or two) exposures during the mission or task
Infrequent	Infrequent exposure during mission or task, but possible

Consequence

Descriptor	Meaning
Catastrophic	Numerous fatalities, significant loss of assets, major disruption to activities or capability loss
Disastrous	Fatalities and significant injuries, significant loss of assets, severe disruption to accomplishment of current mission or task
Serious	Serious injury (amputation and permanent disability). Major damage to assets, compromised ability to complete the mission or task
Minor First Aid treatment	Minor loss or damage to assets, inconvenience to execution of mission or task
Insignificant	Little or no impact

Risk Level

Descriptor	Meaning
Extremely High Very High	Either significant asset or capability loss or mission/task completion unlikely = Unacceptable – eliminate or reduce risk through control measures
High	Significantly degrades mission or task capabilities = Undesirable – risk must be eliminated or reduced
Substantial	Will degrade mission or task without review = Acceptable after review
Medium Moderate	Degrades mission or task = May be acceptable with review
Low	Little or no impact on mission or task capability = Acceptable without review
Very Low Extremely Low	No impact on mission or task = Acceptable without review
