EXPLANATORY STATEMENT

Defence Determination 2001/1

This Determination amends Defence Determination 2000/1, Conditions of Service (“the Principal Determination”), made under section 58B of the *Defence Act 1903*, which includes provisions in Chapter 9 dealing with overseas conditions of service for members of the Australian Defence Force (ADF).

For consistency, the Principal Determination operates in this area by applying most of the provisions of Public Service (Defence) Determination 1999/11, Overseas Conditions of Service, to members of the Australian Defence Force (ADF) as if the members were Australian Public Service employees of the Department of Defence in the same circumstances. Some exceptions are made in Chapter 9 to recognise overseas situations which are specific to ADF service.

This Determination makes various consequential amendments as a result of a range of minor revisions to Public Service (Defence) Determination 1999/11 which took effect on the same date (18 January 2001).

Clause 1 sets out the manner in which this Determination may be cited.

This Determination commences on the day on which it is made (18 January 2001), as provided by subsection 58B (4) of the *Defence Act 1903*.

Clause 2 identifies the Principal Determination as the instrument that is amended by this Determination.

Clause 3 makes a minor typographical correction.

Clauses 4 and 5 extend the scope of a provision setting out the right of members to be reimbursed for expenses incurred in preparing for a posting (including an overseas posting) which is subsequently cancelled for reasons beyond their control. Clause 4 provides for the reimbursement to be available in relation to short-term missions overseas, as well as long-term postings. Clause 5 adds two overseas allowances to the list of relevant allowances which governs the type and amount of expenses for which members are entitled to be reimbursed.

Clause 6 omits a redundant cross-reference.

Clause 7 makes a minor drafting improvement.

Clause 8 omits a redundant provision dealing with conditions for a locality in India where no members are serving.

Clause 9 amends a cross-reference to a revised schedule to Public Service (Defence) Determination 1999/11.
