# EXPLANATORY STATEMENT

## Defence Determination 2001/29

This Determination amends Defence Determination 2000/1, Conditions of Service, made under section 58B of the *Defence Act 1903*, which includes provisions authorising payment of deployment allowances to members of the Australian Defence Force (ADF) assigned for duty with a United Nations mission or similar force. Schedule 14 to that Determination sets out the rates of deployment allowance that apply to members. The rates vary depending on the level of threat applying to a particular deployment.

This Determination replaces Schedule 14 with a new schedule that increases the rates of deployment allowance. The new schedule increases the rates by 2%, in line with an adjustment to the salaries of ADF members with effect from 8 November 2001. (A review in 1999 concluded that rates should be tied to movements in salaries, given the increased significance of deployments to the ADF).

The rates were last varied with effect from 1 March 2001 by Defence Determination 2001/5, which also authorised a 2% increase in line with an ADF salary adjustment.

This Determination commences on 8 November 2001, the same day as the ADF salary increase becomes effective.
