**Uniform Maintenance Allowance**

1. Determination 0601, Uniform Maintenance Allowance, is amended by inserting "a Junior Trainee undergoing a Certificate of Technology course or" at the beginning of paragraph 4(g).

**Recreation Leave**

2. Determination 2601, Recreation Leave, is amended by omitting from the definition of "trainee" in clause 2 "or 10" and substituting ", 10 or 11".

**Leave for Members Under Training**

3. Determination 2602, Leave for Members Under Training, is amended by omitting from the definition of "trainee" in clause 2 "or 10" and substituting ", 10 or 11".

**Recreation Leave Bonus**

4. Determination 2607, Recreation Leave Bonus, is amended—
- (a) by omitting from the definition of "trainee" in clause 2 "Items 3 to 10" and substituting "Items 3 to 11"; and

- (b) by inserting after "Apprentices" in Item 1 of the Schedule to that Determination "or Junior Trainees undergoing a Certificate of Technology course".

EXPLANATORY STATEMENT

DETERMINATION NO. 60 OF 1981

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 provides that the Minister may make determinations on conditions of service which are beneficial to members of the Defence Force.

Determinations 2601, 2602 and 2607, cover, respectively, Recreation Leave, Leave for Members Under Training and Recreation Leave Bonus.

The amendments include reference to provisions applicable to Junior Trainees undergoing a Certificate of Technology course.

Date of effect of the amendment is the date of signature.
