1. Determination 3498, Cadet Forces Allowances, is amended by omitting the Schedule and substituting the following Schedule:

EXPLANATORY STATEMENT

DETERMINATION NO. 49 OF 1982

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service which are beneficial to members of the Defence Force.

Determination 3498, which provides for Cadet Forces Allowances to be paid to officers and instructors of cadets, is amended by increasing the amount payable to those officers and instructors for their commitment to continuous training, home training and administration.

The date of effect is 1 October 1982.
