Insurance on Removal of Urgently Required Household Items

1. Determination 1906, Insurance on Removal of Urgently Required Household Items is amended by omitting from paragraph 6 (d) "\$500" and substituting "\$600".

Insurance on Removal Overseas

2. Determination 2102, Insurance on Removal Overseas is amended—

- (a) by inserting "per annum" after "the amount of reimbursement" in clause 7;
- (b) by omitting from paragraph 7 (a) "\$500" and substituting "\$600";
- (c) by inserting "per annum" after "the amount of reimbursement" in clause 8;
- (d) by omitting from sub-paragraph 8 (a) (i) "\$337.50" and substituting "\$405"; and
- (e) by omitting from sub-paragraph 8 (b) (i) "\$500" and substituting "\$600".

Application

3. This Determination shall apply in respect of insurance costs incurred by a member on or after 1 January 1983.

EXPLANATORY STATEMENT

DETERMINATION NO. 59 OF 1982

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service which are beneficial to members of the Defence Force.

Determination 1906, Insurance on Removal of Urgently Required Household Items, provides for reimbursement up to a certain limit of insurance premiums for urgently required household furniture and effects removed within Australia. Determination 2102, Insurance on Removal Overseas, provides similar reimbursement of insurance premiums for goods removed to and from an overseas locality by members of the Defence Force posted overseas.

This Determination amends Determinations 1906 and 2102 by increasing the limit of reimbursement.

Determination 2102 is also amended to apply the reimbursement limits on insurance premiums annually rather than for the period of the member's posting.
