Determination under Section 58B of the Defence Act 1903¹ (Amendment)

Payments in Lieu of Recreation Leave, War Service Leave, Long Service Leave and Recreation Leave Bonus, Consequent Upon the Death of a Member or Former Member

1. Determination 2699, Payments in Lieu of Recreation Leave, War Service Leave, Long Service Leave and Recreation Leave Bonus, Consequent Upon the Death of a Member or Former Member is amended—

- (a) by omitting paragraph (c) of clause 3 and substituting the following paragraph:
- “(c) in respect of war service leave, under Determination 2606, War Service Leave, made under section 58B of the *Defence Act 1903*;” and
- (b) by omitting paragraph (c) of clause 4 and substituting the following paragraph:
- “(c) in respect of war service leave, under Determination 2606, War Service Leave, made under section 58B of the *Defence Act 1903*;”.

Application

2. This Determination shall apply in relation to service by a member on or after the date on which Determination 2606, War Service Leave is made under section 58B of the *Defence Act* 1903.

EXPLANATORY STATEMENT

DETERMINATION NO. 9 OF 1981

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 provides that the Minister may make determinations on conditions of service which are beneficial to members of the Defence Force.

This determination amends Determination 2699, Payments in Lieu of Recreation Leave, War Service Leave, Long Service Leave and Recreation Leave Bonus, Consequent Upon the Death of a Member or Former Member which makes reference to War Service Leave payable to members of the Defence Force under Naval Financial Regulations 250C, Military Financial Regulation 17C and Air Force Regulation 534.

These regulations have been replaced by Determination 2606 War Service Leave, a tri-service determination which consolidates all the provisions relating to War Service Leave.

This determination makes the necessary consequential amendments to Determination 2699.

The date of effect is the day on which Determination 2606, War Service Leave is made under section 58B of the Defence Act 1903.
