Determination under Section 58B of the Defence Act 1903¹ (Amendment)

Settling In and Settling Out Allowance

1. Determination 3711, Settling In and Settling Out Allowance is amended—

- (a) by inserting in clause 6 “or 35” after “clause 4”; and
- (b) by inserting in Schedule 2 the following entry after the entry relating to “Vanuatu”:

“Western Samoa . . . Dollar . . 25.50 . . 18.50 . . 28.50 . . 21.00”.

Post Allowance

2. Determination 3719, Post Allowance, is amended—

- (a) by omitting from paragraph 4 (a) “\$3,000” and substituting “\$5,000”;
- (b) by omitting from paragraph 4 (b) “\$2,250” and substituting “\$3,750”;
- (c) by omitting from paragraph 4 (c) “\$1,500” and substituting “\$2,750”;
- (d) by omitting paragraphs 5 (a) to 5 (j) inclusive and substituting the following paragraphs:

- “(a) Accra;
- (b) Baghdad;
- (c) Dar-Es-Salaam;
- (d) Dhaka;

- (e) Hanoi;
 - (f) Jeddah/Riyadh;
 - (g) Lagos;
 - (h) Male;
 - (i) Malindi;
 - (j) Peking;
 - (k) Quetta;
 - (l) Rangoon;
 - (m) Tehran;
 - (n) Vientiane; and
 - (o) any locality in Lebanon.”;
- (e) by omitting paragraphs 6 (a) to 6 (k) inclusive and substituting the following paragraphs:
- “(a) Algiers;
 - (b) Ankara;
 - (c) Caracas;
 - (d) Islamabad;
 - (e) Kingston in Jamaica;
 - (f) Lusaka;
 - (g) Moscow;
 - (h) Papua New Guinea;
 - (i) Rawalpindi;
 - (j) Srinagar;
 - (k) Warsaw; and
 - (l) any locality in Syria.”;
- (f) by omitting paragraphs 7 (a) to 7 (s) inclusive and substituting the following paragraphs:
- “(a) Abu Dhabi;
 - (b) Belgrade;
 - (c) Bombay;
 - (d) Cairo;
 - (e) Colombo;
 - (f) Kathmandu;
 - (g) Kiribati;
 - (h) Kuwait;
 - (i) Manama;
 - (j) Nauru;
 - (k) New Delhi;
 - (l) Seoul;
 - (m) Tuvalu;
 - (n) Wellington in India;
 - (o) any locality in Fiji with the exception of Suva and Lautoka;

- (p) any locality in Tonga with the exception of Tonga Tapu Island;
 - (q) any locality in Vanuatu with the exception of Vate Island;
 - (r) any locality in Indonesia;
 - (s) any locality in Jordan; and
 - (t) any locality in Thailand.”;
- (g) by omitting from clause 10 “in excess of one month” and substituting “of one month or more”; and
- (h) by inserting the following clause after clause 10:
“10A. A member who is serving in Hong Kong and who is required to perform duty in the People’s Republic of China for a period of 5 days or more shall be paid Post Allowance at the rate specified in paragraph 4 (a) for the duration of that duty.”.

Application

3. Determination 3711, Settling In and Settling Out Allowance, as amended by paragraph (b) of clause 1 of this Determination, shall apply in relation to service on or after 15 July 1983.

4. Determination 3719, Post Allowance, as amended by paragraphs (a), (b), (c), (d), (e) and (f) of clause 2 of this Determination, shall apply in relation to service on or after 14 July 1983.

EXPLANATORY STATEMENT

DETERMINATION NO. 19 OF 1983

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3711, Settling In and Settling Out Allowance, provides for payment of an allowance to members of the Defence Force posted overseas for long or intermediate term duty who are required to reside temporarily in hotel accommodation at the overseas post.

This Determination amends Determination 3711 to include rates of Settling In and Settling Out Allowance for members who are serving in Western Samoa. The date of effect of this amendment is 15 July 1983. It also makes a minor textual amendment to clarify policy intent.

Determination 3719, Post Allowance, provides for payment of Post Allowance to members of the Defence Force serving in specified localities overseas for a period of more than one month.

This Determination amends Determination 3719:

- (a) to increase the rates of the allowance; to revise the classifications of some localities; and introduces some new localities, effective from 14 July 1983;
- (b) to provide for the payment of Post Allowance to members who serve on short term duty in the People's Republic of China for a period of 5 or more days, effective from the date of signature of the Determination; and
- (c) to make clearer the intention of the policy on the minimum qualifying period for payment of the allowance.
