Trainee Leader's Allowance

1. Determination 0113, Trainee Leader's Allowance is amended—
 - (a) by omitting from Column 2 of the Schedule "Air Cadet Under Officer" and substituting "Officer Cadet Under Officer"; and
 - (b) by omitting from Column 2 of the Schedule "Cadet Aircrew—Course Commander" and substituting "Officer Cadet—Course Commander".

Recreation Leave Bonus

2. Determination 2607, Recreation Leave Bonus is amended by omitting from Item Numbers 3 and 6 to the Schedule "air cadets" and substituting "officer cadets".

Application

3. This Determination shall apply in relation to service by a member on or after 30 December 1983.

EXPLANATORY STATEMENT

DETERMINATION NO. 1 OF 1984

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 provides that the Minister may make determinations on conditions of service for members of the Defence Force.

Determinations 0113 and 2607 cover Trainee Leader's Allowance and Recreation Leave Bonus respectively.

A recent amendment to the Air Force Regulations deleted the rank titles of Air Cadet and Cadet Aircrew and introduced the rank titles of Officer Cadet and Non-commissioned Officer Cadet in their stead. This determination makes consequential amendments to Determinations 0113 and 2607 to permit the payment of Trainee Leader's Allowance and Recreation Leave Bonus to a member holding the new rank of Officer Cadet who satisfies the conditions of payment for the allowance or the bonus. Similar amendments are not necessary with respect to Non-commissioned Officer Cadets as members holding this rank are described in the financial legislation by reference to the training they are undertaking, not by their rank title.

The date of effect is 30 December 1983, the date of legislation amending the Air Force Regulation became effective.
