Application

3. Determination 3610, In Port Allowance—

- (a) as amended by paragraphs 1 (a), 1 (b), 1 (d) and 1 (h) of this Determination—shall apply in relation to service by a member on or after 25 November 1983; and
- (b) as amended by paragraphs 1 (c), 1 (e), 1 (g), 1 (i) and 1 (j) of this Determination—shall apply in relation to service by a member on or after 7 October 1983.

4. Determination 3711, Settling In and Settling Out Allowance—

- (a) as amended by paragraphs 2 (a) and 2 (b) of this Determination—shall apply in relation to service by a member on or after 25 November 1983; and
- (b) as amended by paragraph 2 (c) of this Determination—shall apply in relation to service by a member on or after 15 November 1983.

EXPLANATORY STATEMENT

DETERMINATION No. 7 OF 1984

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3610, In Port Allowance, provides for the payment of an allowance to members of the Defence Force who serve on a sea-going ship while that ship is visiting a foreign port.

This determination amends Determination 3610 to include Mauritius, effective from 7 October 1983, and Belgium and Ireland, effective from 25 November 1983, among those localities for which In Port Allowance is payable; to increase the rates of the allowance payable to members who visit Indonesia, Penang in Malaysia, the Philippines or Singapore, effective from 7 October 1983, and Britain and Mauritius, effective 25 November 1983; and to decrease the rates of In Port Allowance payable to members who visit a port in Malaysia other than Penang, effective from the date of signature of this determination.

Determination 3711, Settling In and Settling Out Allowance, provides for payment of an allowance to members of the Defence Force posted overseas for long or intermediate term duty who are required to reside temporarily in hotel accommodation at the overseas post.

This Determination amends Determination 3711 to introduce rates of the allowance for Belgium, effective from 25 November 1983; increase the rates for Britain, effective from 25 November 1983; and amend the rates of Settling In and Settling Out Allowance payable to members who are serving in the United States of America, effective from 15 November 1983 for those rates which have been increased, and the date of signature of the determination for those rates which have been decreased.
