Determination under Section 58B of the Defence Act 1903¹ (Amendment)

Higher Duties Allowance

1. Determination 0104, Higher Duties Allowance, is amended by inserting after paragraph (a) of the definition of "salary" in clause 2 the following paragraph:

"(b) Determination 0115, Special Allowance for Medical Officers and Dental Officers;"

Recreation Leave

2. Determination 2601, Recreation Leave, is amended—

(a) by inserting before sub-paragraph 36 (a) (ii) the following sub-paragraph:

"(i) Determination 0115, Special Allowance for Medical Officers and Dental Officers;" and

(b) by inserting after "Service Allowance" in paragraph 41 (a) "or Determination 0115, Special Allowance for Medical Officers and Dental Officers".

Recreation Leave Bonus

3. Determination 2607, Recreation Leave Bonus, is amended by inserting after sub-paragraph 3 (d) (vii) the following sub-paragraph:

“(viii) Determination 0115, Special Allowance for Medical Officers and Dental Officers;”.

Long Service Leave

4. Determination 2701, Long Service Leave, is amended—

(a) by omitting from paragraph 22 (c) “Service Allowance, being a Determination” and substituting “Service Allowance and Determination 0115, Special Allowance for Medical Officers and Dental Officers, being Determinations”; and

(b) by inserting before sub-paragraph 23 (a) (ii) the following sub-paragraph:

“(i) Determination 0115, Special Allowance for Medical Officers and Dental Officers;”.

Application

5. This Determination shall apply in relation to service by a member on or after 29 December 1983.

EXPLANATORY STATEMENT

DETERMINATION NO. 8 OF 1984

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 0104, 2601, 2607 and 2701 provide members with entitlements to Higher Duties Allowance, Recreation Leave, Recreation Leave Bonus and Long Service Leave, respectively.

This determination amends Determinations 0104, 2601, 2607 and 2701 to include Special Allowance for Medical Officers and Dental Officers as a consideration when calculating certain entitlements under those Determinations. The re-introduction of Special Allowance for Medical Officers and Dental Officers under Determination 0115 coincides with this determination.

The date of effect is 29 December 1983.
