**Temporary Accommodation Allowance**

1. Determination 0504, Temporary Accommodation Allowance, is amended—

- (a) by omitting from the definitions of "suitable married quarter", "suitable own home" and "suitable premises" in clause 2 "Defence Force Rental Expense Allowance" and substituting "Defence Force Rental Expense Assistance Allowance"; and
- (b) by omitting Schedule 1 and substituting the following Schedule:

EXPLANATORY STATEMENT  
DETERMINATION NO. 1 OF 1985  
ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE  
UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 0504, Temporary Accommodation Allowance, provides for the payment of an allowance where a member and family are moved at Commonwealth expense from one locality to another in Australia and must be temporarily accommodated in a hotel or motel while waiting to move into a permanent residence.

The determination is amended by increasing the rates of board and lodging contributions which a member is required to make towards the cost of the temporary accommodation. The increase is a flow on from a corresponding increase for members of the Australian Public Service. The date of effect is 10 January 1985.

The opportunity has been taken to make a minor textual amendment to determination 0504.
