EXPLANATORY STATEMENT

DETERMINATION NO. 39 OF 1985

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3713, 3714, 3715, 3716 and 3724 provide respectively for payment of the following allowances to a member who is serving on duty overseas:

- a. Intermediate Term Duty Living Allowance;
- b. Overseas Living Out Allowance;
- c. Overseas Living In Allowance;
- d. Supplementary Living Allowance; and
- e. Child Allowance.

This determination amends Determination 3713, 3714, 3715, 3716 and 3724 to:

- a. increase, with effect from 7 March 1985, the rates of Overseas Living Out Allowance, Supplementary Living Allowance and Child Allowance, payable to members serving in Britain, Fiji, Pakistan or the Solomon Islands and Intermediate Term Duty Living Allowance and Overseas Living In Allowance payable to members serving in Britain;
- b. increase, with effect from 21 March 1985, the rates of Overseas Living Out Allowance, Supplementary Living Allowance and Child Allowance, payable to members serving in Britain, France, Germany, India or Singapore; the rates of Intermediate Term Duty Living Allowance payable to members serving in Britain or France; and the rates of Overseas Living In Allowance payable to members serving in Britain or Germany; and

- c. change the rates of Overseas Living Out Allowance, Supplementary Living Allowance and Child Allowance payable to members serving in Papua New Guinea with effect 21 March 1985, except for a particular rate of Supplementary Living Allowance which is a decrease and which is effective from the date of making of the Determination.
