EXPLANATORY STATEMENT

DETERMINATION NO. 59 OF 1985

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3601, Travelling Allowance, provides for the payment of an allowance to a member of the Defence Force proceeding overseas on duty to cover costs of accommodation, meals and incidental expenses which he or she incurs.

Determination 3610, In Port Allowance, provides for the payment of an allowance to a member of the Defence Force who serves on a sea-going ship while that ship is visiting a foreign port.

Determination 3711, Settling In and Settling Out Allowance, provides for payment of an allowance to a member of the Defence Force who is posted overseas for a period likely to exceed 6 months and who is required to reside temporarily in hotel accommodation at the overseas post.

Determination 3731, Meal Allowance Overseas, provides for the reimbursement of the meal costs incurred by a member of the Defence Force in certain circumstances when serving overseas.

This Determination amends Determinations 3601, 3610, 3711 and 3731:

- a. in respect of a member serving in Nauru, to increase the rates of Travelling Allowance, In Port Allowance, Meal Allowance Overseas and a particular rate of Settling In and Settling Out Allowance, with effect from 23 April 1985; and to decrease with effect from the date of signature of this determination certain other rates of Settling In and Settling Out Allowance; and

- b. in respect of a member serving in Tonga, to increase the rates of Travelling Allowance and certain rates of Settling In and Settling Out Allowance, with effect from 15 April 1985; and to decrease Travelling Allowance for travel within country, In Port Allowance, Meal Allowance and certain rates of Settling In and Settling Out Allowance, with effect from the date of signature of this determination.
