EXPLANATORY STATEMENT

DETERMINATION NO. 11 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3601, Travelling Allowance, Determination 3610, In Port Allowance, Determination 3711, Settling In and Settling Out Allowance and Determination 3731, Meal Allowance Overseas, provide for allowances to reimburse the travelling costs of members of the Defence Force serving on duty overseas or to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas.

This determination amends the rates of these allowances which are payable to members serving on duty in the countries mentioned in the following paragraphs.

Clauses 1, 2 and 7 of this determination amend Determination 3601, Travelling Allowance:

- a. to increase from 11 November 1985 the rates payable in Kenya;
- b. to introduce from 21 November 1985 a new incidental rate of this allowance for travel within Norway and also to increase the rates payable in Norway;
- c. to introduce from 2 December 1985 a new incidental rate of this allowance for travel within New Zealand and also to increase the rates payable in New Zealand; and
- d. to increase from 7 January 1986 the rates payable in the Netherlands.

Clauses 3 and 8 of this determination amend Determination 3610 to vary the rates of In Port Allowance:

- a. by increasing, with effect from 11 November 1985, the rates payable in Kenya;
- b. by increasing, with effect from 21 November 1985, the rates payable in Norway;
- c. by increasing, with effect from 2 December 1985 the rates payable in New Zealand; and
- d. by decreasing, with effect from the date of signature of this determination, the rates payable in the Netherlands.

Clauses 4 and 9 of this determination amend Determination 3711 to increase the rates of Settling In and Settling Out Allowance payable to members serving:

- a. in New Zealand, with effect from 2 December 1985; and
- b. in the Netherlands, with effect from 7 January 1986.

Clauses 5 and 10 of this determination amend Determination 3731 to increase the rates of Meal Allowance Overseas for members serving:

- a. in Pakistan, with effect from 26 June 1985;
- b. in Kenya, with effect from 11 November 1985;
- c. in Norway, with effect from 21 November 1985;
- d. in New Zealand, with effect from 2 December 1985; and
- e. in the Netherlands, with effect from 7 January 1986.

Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, provides for the reimbursement of certain costs incurred by a member of the Defence Force while serving in an overseas country.

Clause 6 of this determination amends Determination 3901 to increase the rates of Gardening Assistance Allowance payable in Western Samoa with effect from the date of signature of this determination.
