EXPLANATORY STATEMENT

DETERMINATION NO. 12 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3498, Cadet Forces Allowances, provides for payment of training, travelling and other like allowances to officers and instructors of the Cadet Forces.

This Determination amends Determination 3498 by increasing the amount payable to such officers and instructors with effect 1 October 1985.
