EXPLANATORY STATEMENT

DETERMINATION No. 13 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3601, Travelling Allowance, Determination 3610, In Port Allowance and Determination 3711, Settling In and Settling Out Allowance, provide allowances to reimburse the travelling costs of members serving on duty overseas or to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas.

This determination amends Determinations 3601, 3610 and 3711 to increase the rates of these allowances payable to members serving in India, with effect from 10 December 1985, and also to decrease the B rate of Travelling Allowance payable to members serving in New Delhi, India, with effect from the date of signature of this determination.
