EXPLANATORY STATEMENT

DETERMINATION NO. 14 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 0602, Outfit Allowance, provides for payment of an allowance to officers and sailors of the Permanent Naval Forces for the initial purchase of a uniform, the purchase of additional uniform items or to have necessary alterations made to the uniform.

Paragraphs 1(a), 1(b), 1(c) and 1(d) of this determination amend clause 2 and 4 of Determination 0602 to omit reference to Reserve Force members as they are no longer entitled to this allowance with effect from the date of signature of this determination.

Paragraphs 1(e), 1(f), 1(g), 1(h), 1(i), 1(j), 1(k) and 1(m) of this determination amend clause 5, 7 and 12 of Determination 0602 to omit reference to members who have successfully completed flying training as they are no longer entitled to this allowance with effect from the date of signature of this determination.

Paragraph 1(l) and clause 2 of this determination amend clause 8 of Determination 0602 to change "class" to "type" of uniform with effect from 15 July 1985.

Paragraph 1(n) and clause 2 of this determination amend the Schedules to Determination 0602 to increase certain rates of this allowance with effect from 15 July 1985.

Paragraphs 1(o), 1(p), 1(q), 1(r) and 1(s) of this determination amend the Schedules to Determination 0602 to delete certain rates of the allowance which are no longer applicable and to decrease certain other rates with effect from the date of signature of this determination.
