District Allowance

1. Determination 0301, District Allowance, is amended—

(a) by omitting the table from clause 4 and substituting the following table:

(b) by omitting from the table in clause 5—

"Tennant Creek C"

and substituting—

"Tennant Creek D"

Vehicle Allowance

2. Determination 0402, Vehicle Allowance, is amended by omitting from column 3 of the table in clause 21—

- (a) "29.9" and substituting "32.8";
- (b) "28.2" and substituting "31.0";
- (c) "23.2" and substituting "25.5"; and
- (d) "20.8" and substituting "22.8".

Application

3. Clause 1 of this Determination shall apply in relation to service by a member from and including 1 May 1985.

4. Clause 2 of this Determination shall apply in relation to service by a member from and including 4 December 1985.

EXPLANATORY STATEMENT

DETERMINATION NO. 15 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 0301, District Allowance, provides for payment of an allowance to members serving in localities classified by the Australian Public Service Board as being isolated districts. The rate of allowance payable depends on the particular grade in which a locality has been classified.

Clauses 1 and 3 of this determination amend Determination 0301, with effect from 1 May 1985, to increase the rates at which this allowance is payable and to increase the classification for Tennant Creek from a Grade C locality to a Grade D locality.

Determination 0402, Vehicle Allowance, provides for payment of an allowance to members of the Defence Force who are authorized to use their privately owned vehicles on travel which would otherwise be at Commonwealth expense.

Clauses 2 and 4 of this determination amend Determination 0402 by increasing the rates at which the allowance is payable with effect from 4 December 1985.
