EXPLANATORY STATEMENT

DETERMINATION NO. 16 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3713, 3714, 3715, 3716 and 3724 provide respectively for the payment of:

- a. Intermediate Term Duty Living Allowance;
- b. Overseas Living Out Allowance;
- c. Overseas Living In Allowance;
- d. Supplementary Living Allowance; and
- e. Child Allowance,

to members of the Defence Force who are serving on duty overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas.

This determination amends the rates of these allowances which are payable to members serving on duty in the countries mentioned in the following paragraphs.

Clauses 1 and 6 of this determination amend Determination 3713 to decrease the rates of Intermediate Term Duty Living Allowance payable from 20 March 1986 to members serving in Canada.

Clauses 2 and 7 of this determination amend Determination 3714 to vary the rates of Overseas Living Out Allowance payable to members serving overseas:

- a. by increasing, with effect from 26 December 1985, the rates payable in France or Germany; and
- b. by decreasing, with effect from 20 March 1986, the rates payable in Canada, New Zealand, the Philippines or Western Samoa.

Clauses 3 and 8 of this determination amend Determination 3715 to vary the rates of Overseas Living In Allowance payable to members serving overseas:

- a. by increasing, with effect from 26 December 1985, the rates payable in Germany;
- b. by introducing various rates payable in New Zealand from 6 January 1986, 23 January 1986, 20 February 1986 and 20 March 1986 ; and
- c. by decreasing, with effect from 20 March 1986, the rates payable in Canada.

Clauses 4 and 9 of this determination amend Determination 3716 to vary the rates of Supplementary Living Allowance payable to members serving overseas:

- a. by increasing, with effect from 26 December 1985, the rates payable in France or Germany; and
- b. by decreasing, with effect from 20 March 1986, the rates payable in Canada, New Zealand, the Philippines or Western Samoa.

Clauses 5 and 10 of this determination amend Determination 3724 to vary the rates of Child Allowance payable to members serving overseas:

- a. by increasing, with effect from 26 December 1985, the rates payable in France or Germany; and
- b. by decreasing, with effect from 20 March 1986, the rates payable in Canada, the Philippines, or Western Samoa.
