EXPLANATORY STATEMENT

DETERMINATION NO. 17 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3713, 3714, 3715, 3716, 3718 and 3724 provide for the payment of:

- a. Intermediate Term Duty Living Allowance;
- b. Overseas Living Out Allowance;
- c. Overseas Living In Allowance;
- d. Supplementary Living Allowance;
- e. Overseas Rental and Utilities Allowance; and
- f. Child Allowance,

to members of the Defence Force to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas.

This determination amends the rates of these allowances payable to members serving on duty in the countries mentioned in the following paragraphs.

Clauses 1 and 8 of this determination amend Determination 3713 to decrease, with effect from 3 April 1986, the rates of Intermediate Term Duty Living Allowance payable to members serving in Britain or the United States of America.

Clauses 2, 3 and 9 of this determination amend Determination 3714 to vary the rates of Overseas Living Out Allowance payable to members serving:

- a. in the Netherlands, by increasing the rates with effect from 26 December 1985;
- b. in Japan, by increasing certain rates with effect from 6 February 1986 and then by decreasing other rates with effect from 3 April 1986; and
- c. in Beirut, Britain, China, Egypt, Fiji, Hong Kong, Indonesia, Israel, Malaysia, Singapore, Syria, Thailand or the United States of America, by decreasing the rates with effect from 3 April 1986.

Clauses 4 and 10 of this determination amend Determination 3715 to decrease, with effect from 3 April 1986, the rates of Overseas Living In Allowance payable to members serving in Britain, Hong Kong, Malaysia or the United States of America.

Clauses 5 and 11 of this determination amend Determination 3716 to vary the rates of Supplementary Living Allowance payable to members serving:

- a. in the Netherlands, by increasing the rates with effect from 26 December 1985;
- b. in Japan, by increasing certain rates with effect from 6 February 1986 and then by decreasing other rates with effect from 3 April 1986; and
- c. in Britain, Fiji, Hong Kong, Indonesia, Malaysia, Singapore, Thailand or the United States of America, by decreasing the rates with effect from 3 April 1986.

Clauses 6 and 12 of this determination amend Determination 3718 to vary the rates of Overseas Rental and Utilities Allowance payable to members serving:

- a. in Syria, by increasing certain rental ceilings with effect from 28 November 1985 and then by decreasing these same rental ceilings with effect from 3 April 1986;
- b. in Egypt, by decreasing the rental ceilings with effect from 3 April 1986; and
- c. in Israel, by decreasing certain rental ceilings with effect from 3 April 1986.

Clauses 7 and 13 of this determination amend Determination 3724 to vary the rates of Child Allowance payable to members serving:

- a. in the Netherlands, by increasing the rates with effect from 26 December 1985;
- b. in Japan, by increasing the rates with effect from 6 February 1986; and
- c. in Britain, China, Egypt, Fiji, Hong Kong, Indonesia, Israel, Malaysia, Singapore, Syria, Thailand or the United States of America, by decreasing the rates with effect from 3 April 1986.
