Overseas Living Out Allowance

1. Schedule 2 to Determination 3714, Overseas Living Out Allowance, is amended as set out in the following table:

3. The Schedule to Determination 3724, Child Allowance, is amended by omitting the entry relating to Egypt, and substituting—

"Egypt 1,570 1,520".

4. Determination 3714, Overseas Living Out Allowance, as amended by—

- (a) item 2 of the table in clause 1—shall apply in relation to service by a member from and including 14 November 1985; and
- (b) item 1 of the table in clause 1—shall apply in relation to service by a member from and including 23 January 1986.

5. Determination 3718, Overseas Rental and Utilities Allowance, as amended by clause 2 of this Determination shall apply in relation to service by a member from and including 23 January 1986.

6. Determination 3724, Child Allowance, as amended by clause 3 of this Determination shall apply in relation to service by a member from and including 14 November 1985.

EXPLANATORY STATEMENT

DETERMINATION NO. 2 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3714, 3718 and 3724 provide respectively for payment of:

- a. Overseas Living Out Allowance;
- b. Overseas Rental and Utilities Allowance; and
- c. Child Allowance,

to members of the Defence Force who are serving on duty overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas.

This determination amends the rates of these allowances which are payable to members serving on duty in the countries mentioned in the following paragraphs.

Clauses 1 and 4 of this determination amend Determination 3714, Overseas Living Out Allowance:

- a. by increasing, with effect from 14 November 1985, the rates payable to members serving in Beirut; and
- b. by decreasing, with effect from 23 January 1986, the rates payable to members serving in Egypt.

Clauses 2 and 5 of this determination amend Determination 3718, Overseas Rental and Utilities Allowance, to decrease, with effect from 23 January 1986, some of the rent ceilings applicable to members serving in Egypt.

Clauses 3 and 6 of this determination amend Determination 3724, Child Allowance, to increase, with effect from 14 November 1985, the rates payable to members serving in Egypt.
