EXPLANATORY STATEMENT

DETERMINATION NO. 24 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3714, 3716 and 3724 provide respectively for the payment of:

- a. Overseas Living Out Allowance;
- b. Supplementary Living Allowance; and
- c. Child Allowance,

to members of the Defence Force to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that overseas service.

This determination amends the rates of these allowances which are payable to members serving on duty in the countries mentioned in the following paragraphs.

Clauses 1, 2 and 5 of this determination amend Determination 3714 to vary the rates of Overseas Living Out Allowance payable to members serving overseas:

- a. by progressively increasing, with effect from 7 February 1985, 21 March 1985, 4 April 1985 and 31 October 1985, the rates in India; and
- b. by increasing, with effect from 6 March 1986, the rates in Papua New Guinea.

Clauses 3 and 6 of this determination amend Determination 3716 to vary the rates of Supplementary Living Allowance payable to members serving overseas:

- a. by progressively increasing, with effect from 7 February 1985, 21 March 1985, 4 April 1985, 30 May 1985 and 31 October 1985, the rates in India;
- b. by decreasing, with effect from the date of signature of this determination, some of the rates in India; and
- c. by increasing most rates in Papua New Guinea with effect from 6 March 1986, and by decreasing one rate from the date of signature of the determination.

Clauses 4 and 7 of this determination amend Determination 3724 to vary the rates of Child Allowance payable to members serving overseas:

- a. by progressively increasing, with effect from 7 February 1985, 21 March 1985 and 4 April 1985, the rates in India; and
- b. by increasing, with effect from 6 March 1986, the rates in Papua New Guinea.
