Child Allowance

3. The Schedule to Determination 3724, Child Allowance, is amended by omitting the entry relating to the Philippines and substituting the following entry—

EXPLANATORY STATEMENT

DETERMINATION No. 26 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3714, 3716 and 3724 provide respectively for the payment of:

- a. Overseas Living Out Allowance;
- b. Supplementary Living Allowance: and
- c. Child Allowance,

to members of the Defence Force who are serving on duty overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that overseas service.

Clause 1 of this determination amends Determination 3714 to increase the rates of Overseas Living Out Allowance, with effect from 17 April 1986, payable to members serving in the Philippines.

Clause 2 of this determination amends Determination 3716 to increase the rates of Supplementary Living Allowance, with effect from 17 April 1986, payable to members serving in the Philippines.

Clause 3 of this determination amends Determination 3724 to increase the rates of Child Allowance, with effect from 17 April 1986, payable to members serving in the Philippines.
