EXPLANATORY STATEMENT

DETERMINATION NO. 3 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3714, 3716 and 3724, provide respectively for payment of:

- a. Overseas Living Out Allowance;
- b. Supplementary Living Allowance; and
- c. Child Allowance,

to members of the Defence Force who are serving on duty overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that overseas service.

This determination amends the rates of these allowances which are payable to members serving on duty in the countries mentioned in the following paragraphs.

Clauses 1 and 4 of this determination amend Determination 3714, Overseas Living Out Allowance:

- a. by increasing progressively, with effect from 16 May 1985, 13 June 1985, 25 July 1985, 8 August 1985, 3 October 1985 and 31 October 1985, the rates payable in New Zealand;
- b. by increasing, with effect from 14 November 1985, the rates payable in Egypt, the Philippines or the Solomon Islands;
- c. by increasing, with effect from 12 December 1985, the rates payable in Korea; and
- d. by decreasing, with effect from 23 January 1986, the rates payable in New Zealand.

Clauses 2 and 5 of this determination amend Determination 3716,

Supplementary Living Allowance:

- a. by increasing progressively, with effect from 16 May 1985, 13 June 1985, 25 July 1985, 8 August 1985, 3 October 1985 and 31 October 1985, certain rates payable in New Zealand;
- b. by increasing, with effect from 14 November 1985, the rates payable in the Philippines or the Solomon Islands; and
- c. by decreasing, with effect from 23 January 1986, certain rates payable in New Zealand.

Clauses 3 and 6 of this determination amend Determination 3724,

Child Allowance:

- a. by increasing, with effect from 31 October 1985, the rates payable in New Zealand;
- b. by increasing, with effect from 14 November 1985, the rates payable in the Philippines or the Solomon Islands;
- c. by increasing, with effect from 12 December 1985, the rates payable in Korea; and
- d. by decreasing, with effect from 23 January 1986, the rates payable in New Zealand.
