Education Allowance

1. Determination 0501, Education Allowance, is amended—

- (a) by omitting from paragraph 8 (a) "564" and substituting "601";
- (b) by omitting from paragraph 8 (a) "2646" and substituting "2849";
- (c) by omitting from paragraph 8 (c) "1290" and substituting "1925";
- (d) by omitting from clause 9 "210" and substituting "218"; and
- (e) by omitting from clause 9 "3090" and substituting "3877".

Education Assistance Overseas

2. Determination 3725, Education Assistance Overseas, is amended—

- (a) by omitting from sub-paragraph 11 (a) (i) "466" and substituting "491";
- (b) by omitting from sub-paragraph 11 (a) (ii) "293" and substituting "306";

- (c) by omitting from sub-paragraph 11 (b) (i) "248" and substituting "252";
- (d) by omitting from sub-paragraph 11 (b) (ii) "128" and substituting "133";

- (f) by omitting from sub-paragraph 17 (a) (ii) "269" and substituting "306";
- (g) by omitting from sub-paragraph 17 (b) (i) "230" and substituting "252"; and
- (h) by omitting from sub-paragraph 17 (b) (ii) "119" and substituting "133".

Child Education Allowance

3. Determination 3726, Child Education Allowance, is amended—

- (a) by omitting from paragraph 6 (a) "564" and substituting "601";
- (b) by omitting from paragraph 6 (a) "2646" and substituting "2849";
- (c) by omitting from paragraph 6 (c) "1290" and substituting "1925";
- (d) by omitting from clause 7 "210" and substituting "218"; and
- (e) by omitting from clause 7 "3090" and substituting "3877".

Application

4. Paragraphs 1 (b), 1 (c), 1 (e), 3 (b), 3 (c) and 3 (e) of this Determination shall apply in respect of the attendance of a member's child at a school on or after 1 January 1985.

5. Clause 2 and paragraphs 1 (a), 1 (d), 3 (a) and 3 (d) of this Determination shall apply in respect of the attendance of a member's child at a school on or after 28 January 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 4 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 0501, 3725 and 3726 provide respectively for the payment of:

- a. an education allowance to a member of the Defence Force who is posted from one locality to another in Australia and maintains a child at a secondary school in a locality other than the locality of the posting to prevent disruption to the child's education;
- b. financial assistance to a member of the Defence Force who is posted overseas on long term duty and incurs certain costs in educating a child overseas; and
- c. a child education allowance to a member of the Defence Force who is posted overseas and maintains a child over the age of 9 at a school in Australia.

The determinations each provide for assessment of the allowance or assistance based on the number of weeks per term spent at school, the payment by a member of an initial amount of the cost of the education and a maximum prescribed rate of the allowance.

This determination amends Determinations 0501, 3725 and 3726 by increasing the amount paid by the member and the prescribed maximum rates of allowances to accord with amended rates for the Australian Public Service.

The date of effect is 1 January 1985, except for the increase in the amount paid by the member, which takes effect on 28 January 1986.
