EXPLANATORY STATEMENT

DETERMINATION NO. 40 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3714, 3715, 3716 and 3724 provide for the payment of:

- a. Overseas Living Out Allowance;
- b. Overseas Living In Allowance;
- c. Supplementary Living Allowance; and
- d. Child Allowance,

to members of the Defence Force to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas.

Clauses 1 and 5 of this determination amend Determination 3714, Overseas Living Out Allowance, payable to members serving overseas:

- a. by increasing, with effect from 17 April 1986, the rates in Japan and New Zealand;
- b. by increasing, with effect from 29 May 1986, the rates in France, Germany and the Netherlands; and
- c. by decreasing, with effect from 26 June 1986, the rates in Fiji.

Clauses 2 and 6 of this determination amend Determination 3715, Overseas Living In Allowance, payable to members serving overseas:

- a. by increasing, with effect from 17 April 1986, the rates in New Zealand; and
- b. by increasing, with effect from 29 May 1986, the rates in Germany.

Clauses 3 and 7 of this determination amend Determination 3716, Supplementary Living Allowance, payable to members serving overseas:

- a. by increasing, with effect from 17 April 1986, the rates in Japan and most of the rates in New Zealand;
- b. by increasing, with effect from 29 May 1986, the rates in France, Germany and the Netherlands; and
- c. by decreasing, with effect from 26 June 1986, the rates in Fiji.

Clauses 4 and 8 of this determination amend Determination 3724, Child Allowance, payable to members serving overseas:

- a. by increasing, with effect from 17 April 1986, the rates in Japan;
- b. by increasing, with effect from 29 May 1986, the rates in France, Germany and the Netherlands; and
- c. by decreasing, with effect from 26 June 1986, the rates in Fiji.
