**Meal Allowance Overseas**

4. The Schedule to Determination 3731, Meal Allowance Overseas, is amended by omitting the entry relating to the Philippines and substituting—  
"Philippines . . .Peso . . .158".

EXPLANATORY STATEMENT

DETERMINATION NO.44 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3601, Travelling Allowance, Determination 3610, In Port Allowance, Determination 3711, Settling In and Settling Out Allowance and Determination 3731, Meal Allowance Overseas, provide for payment of allowances which reimburse the additional travelling costs incurred by members of the Defence Force serving on duty overseas.

Paragraph 1(b) and clause 5 of this determination introduce a new rate of Travelling Allowance and increase the existing rate, with effect from 14 April 1986, payable to members serving in the Philippines.

Paragraph 1(a) and clauses 2, 3, 4 and 5 of this determination increase from 14 April 1986 the rates of these allowances payable to members serving in the Philippines.
