Determination under Section 58B of the Defence Act 1903¹ (Amendment)

Bounty Payable to Members of the Emergency Reserve

1. Determination 0799, Bounty Payable to Members of the Emergency Reserve, is amended—

- (a) by inserting before the definition of "Emergency Reserve" in clause 2 the following definition:
" 'Chief of Staff' means—
 - (a) in relation to a member of the Navy—the Chief of Naval Staff;
 - (b) in relation to a member of the Army—the Chief of the General Staff; and
 - (c) in relation to a member of the Air Force—the Chief of the Air Staff;";
- (b) by omitting from clause 4 "Where" and substituting "Subject to clause 4A, where";
- (c) by omitting from paragraph 4 (b) "his" and substituting ", or is deemed to have completed, his or her"; and
- (d) by inserting after clause 4 the following clause:

"4A. A member shall be deemed to have completed his or her training obligation or obligations when the Chief of Staff does not require that member to undergo a period of training in respect of that period of service."

Further Amendments

2. Determination 0799, Bounty Payable to Members of the Emergency Reserve, is further amended as set out in the Schedule.

Clause 2

Provisions amended	Amendments
Clauses 4 and 9	Omit "he" (wherever occurring) and substitute "the member".
Clauses 5 and 6	Insert "or she" after "he" (wherever occurring).
Clause 7	Insert "or her" after "his" (wherever occurring).
Clause 8	Insert "or her" after "his" (first and fifth occurring).
Clause 8	Omit "his" (second, third and fourth occurring) and substitute "the member's".
Clause 8	Insert "or she" after "he" (first and last occurring).
Clause 8	Omit "he" (second occurring) and substitute "the member".
Clause 9	Insert "or her" after "his" (first, second and sixth occurring).
Clause 9	Omit "his" (third, fourth and fifth occurring) and substitute "the member's".

EXPLANATORY STATEMENT

DETERMINATION NO. 45 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 0799, Bounty Payable to Members of the Emergency Reserve, provides for the payment of a bounty to members of the Emergency Reserve upon completion of each year's service provided that the member has completed his or her training obligation.

Clause 1 of this determination amends Determination 0799 to provide for payment of the bounty to members of the Emergency Reserve who are not required by the Chief of Staff to undergo a training obligation by deeming these members to have met the training obligation required by paragraph 4 (b) of Determination 0799.

Clause 2 of this determination further amends Determination 0799 to effect minor textual amendments which remove discriminatory language.

The date of effect is the date on which this determination is made.
