Overseas Living Out Allowance

1. The table in clause 19 of Determination 3714, Overseas Living Out Allowance, is amended by omitting the entry relating to Pakistan and substituting—

"Pakistan Quetta 5 8,520 Nil".

5. Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, is amended—

- (a) by inserting after "purchases" in paragraph 15 (c) "new";
- (b) by inserting after "appliances or" in paragraph 15 (c) "new"; and
- (c) by omitting from paragraph (c) of the formula in clause 15 "569" and substituting "597".

Application

6. Clauses 1, 2, 3 and 4 of this Determination shall apply in relation to service by a member from and including 24 July 1986.

7. Paragraph 5 (c) of this Determination shall apply in relation to service by a member from and including 1 May 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 48 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3714, 3716, 3724 and 3901 provide for the payment of:

- a. Overseas Living Out Allowance;
- b. Supplementary Living Allowance;
- c. Child Allowance; and
- d. Complementary Allowances Payable to Member Serving on Duty Overseas,

to members of the Defence Force serving overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas.

Clauses 1, 2 and 6 of this determination amend Determination 3714 to decrease, with effect from 24 July 1986, the rates of Overseas Living Out Allowance payable to members serving in Korea or Pakistan.

Clauses 3 and 6 of this determination amend Determination 3716 to decrease, with effect from 24 July 1986, the rates of Supplementary Living Allowance payable to members serving in Pakistan.

Clauses 4 and 6 of this determination amend Determination 3724 to decrease, with effect from 24 July 1986, the rates of Child Allowance payable to members serving in Korea or Pakistan.

Clauses 5 and 7 of this determination amend Determination 3901 by:

- a. potentially increasing, with effect from 1 May 1986, the amount that a member who is serving on duty in Britain may be reimbursed for the purchase of furniture and household appliances; and
- b. introducing with effect from the date on which the determination is signed a provision that reimbursement will only be made in respect of the purchase of new furniture and new household appliances.
