### Sinai Allowance

1. Determination 3996, Sinai Allowance, is amended by inserting after clause 5 the following clause:

“6. Where a member was eligible to be paid a Sinai Allowance under clause 2 in respect of a day during a period specified in column 1 of the following table, the member shall be paid in respect of that day an additional amount of Sinai Allowance equal to the amount, if any, by which the daily rate specified in column 2 of that table opposite to that period exceeds the daily rate that was payable to the member in respect of that day under clause 2:

Column 1 Period	Column 2 Daily rate
27 December 1984 to 6 February 1985 inclusive . . . . .	\$12.40
7 February 1985 to 20 February 1985 inclusive. . . . .	\$13.80
21 February 1985 to 20 March 1985 inclusive . . . . .	\$14.70

**Other Amendments**

2. Determination No. 21 of 1986 is amended by omitting from Schedule 2—

"Paragraph 3 (a) . . . . . Omit "he" and substitute "the child's"."

and substituting—

"Paragraph 3 (c) . . . . . Omit "he" and substitute "the child"."

**Application**

3. Clause 2 shall apply from and including 17 April 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 50 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3996, Sinai Allowance, provides for the payment of Sinai Allowance to a member of the Defence Force who was serving with the Australian Contingent Multi-National Force and Observers in Sinai.

Clause 1 of this determination amends Determination 3996 to provide for payment of an additional amount of Sinai Allowance for the periods 27 December 1984 to 6 February 1985; 7 February 1985 to 20 February 1985; and 21 February 1985 to 20 March 1985. These additional amounts reflect currency movements for the specified periods.

Clauses 2 and 3 of this determination amend Determination No. 21 of 1986 to correct a textual error with effect from 17 April 1986, the date on which it was made.
