- (b) items 1, 2, 3, 4 and 5 of the table in clause 2—shall apply in relation to service by a member from and including 7 August 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 51 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3713, 3714, 3715, 3716 and 3724 provide for the payment of:

- a. Intermediate Term Duty Living Allowance;
- b. Overseas Living Out Allowance;
- c. Overseas Living In Allowance;
- d. Supplementary Living Allowance; and
- e. Child Allowance,

to members of the Defence Force serving on duty overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas.

Clauses 1 and 6 of this determination amend Determination 3713, Intermediate Term Duty Living Allowance, by increasing, with effect from 29 May 1986, the rates payable to members serving in Houston or Honolulu.

Clauses 2 and 7 of this determination amend Determination 3714, Overseas Living Out Allowance, payable to members serving overseas:

- a. by increasing, with effect from 29 May 1986, the rates in Honolulu, Houston and Vanuatu; and
- b. by decreasing, with effect from 7 August 1986, the rates in France, Germany, the Netherlands and New Zealand.

Clauses 3 and 8 of this determination amend Determination 3715, Overseas Living In Allowance, payable to members serving overseas:

- a. by increasing, with effect from 29 May 1986, the rates in Honolulu and Houston; and
- b. by decreasing, with effect from 7 August 1986, the rates in Germany and New Zealand.

Clauses 4 and 9 of this determination amend Determination 3716, Supplementary Living Allowance, payable to members serving overseas:

- a. by increasing, with effect from 29 May 1986, the rates in Vanuatu and some of the rates in Honolulu and Houston; and
- b. by decreasing, with effect from 7 August 1986, the rates in France, Germany and the Netherlands, and most of the rates in New Zealand.

Clauses 5 and 10 of this determination amend Determination 3724, Child Allowance, payable to members serving overseas:

- a. by increasing, with effect from 29 May 1986, the rates in Honolulu, Houston and Vanuatu; and
- b. by decreasing, with effect from 7 August 1986, the rates in France, Germany, and the Netherlands.
