7. Determination 3610, In Port Allowance, as amended by clause 3 of this Determination shall apply in relation to service by a member from and including 30 June 1986.

8. Determination 3711, Settling In and Settling Out Allowance, as amended by clause 4 of this Determination shall apply in relation to service by a member from and including 30 June 1986.

9. Determination 3731, Meal Allowance Overseas, as amended by clause 5 of this Determination shall apply in relation to service by a member from and including 30 June 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 52 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3601, Travelling Allowance, Determination 3610, In Port Allowance, Determination 3711, Settling In and Settling Out Allowance and Determination 3731, Meal Allowance Overseas, provide for payment of allowances which reimburse the additional travelling costs incurred by members of the Defence Force serving on duty overseas.

Clauses 1, 2 and 6 of this determination amend Determination 3601, Travelling Allowance, payable to members serving overseas:

- a. by introducing, with effect from 30 June 1986, a new B rate of this allowance to reimburse the cost of meals and incidental expenses for members serving in Cyprus;
- b. by increasing, with effect from 30 June 1986, the existing rates in Cyprus and some of the rates in Syria; and
- c. by decreasing, with effect from 21 August 1986, other rates in Syria.

Clauses 3 and 7 of this determination amend Determination 3610, In Port Allowance, payable to members serving overseas:

- a. by increasing, with effect from 30 June 1986, the rates in Cyprus; and
- b. by introducing, with effect from 30 June 1986, new rates for Syria.

Clauses 4 and 8 of this determination amend Determination 3711, Settling In and Settling Out Allowance, payable to members serving overseas:

- a. by introducing, with effect from 30 June 1986, new rates for Cyprus; and
- b. by increasing, with effect from 30 June 1986, the rates in Syria.

Clauses 5 and 9 of this determination amend Determination 3731, Meal Allowance Overseas, payable to members serving overseas:

- a. by introducing, with effect from 30 June 1986, new rates for Cyprus; and
- b. by increasing and by changing the unit of currency, with effect from 30 June 1986, the rates in Syria.
