EXPLANATORY STATEMENT
DETERMINATION NO. 54 OF 1986
ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE
UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

The following Determinations provide for the payment of allowances to members of the Defence Force who are serving overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas:

- a. Determination 3713, Intermediate Term Duty Living Allowance;
- b. Determination 3714, Overseas Living Out Allowance;
- c. Determination 3715, Overseas Living In Allowance;
- d. Determination 3716, Supplementary Living Allowance;
- e. Determination 3718, Overseas Rental and Utilities Allowance; and
- f. Determination 3724, Child Allowance.

Clauses 1 and 8 of this determination amend Determination 3713 by increasing, with effect from 12 June 1986, the rates of Intermediate Term Duty Living Allowance payable to members serving in Britain, Canada or the United States of America.

Clauses 2, 3 and 9 of this determination amend Determination 3714:

- a. by introducing, with effect from 12 June 1986, rates of Overseas Living Out Allowance payable to members serving in Italy;
- b. by increasing, with effect from 12 June 1986, the rates of Overseas Living Out Allowance payable to members serving in Beirut (where the family of the member resides in Israel), Britain, Canada, China, Hong Kong, Indonesia, Israel, Japan, Malaysia, Singapore, Switzerland, Thailand or the United States of America; and
- c. by decreasing, with effect from 21 August 1986, the rates of Overseas Living Out Allowance payable to members serving in Beirut (where the family of the member resides in Syria) or Syria.

Clauses 4 and 10 of this determination amend Determination 3715 to increase, with effect from 12 June 1986, the rates of Overseas Living In Allowance payable to members serving in Britain, Canada, Hong Kong, Malaysia or the United States of America.

Clauses 5 and 11 of this determination amend Determination 3716:

- a. by introducing, with effect from 12 June 1986, rates of Supplementary Living Allowance for members serving in Italy;
- b. by increasing, with effect from 12 June 1986, the rates of Supplementary Living Allowance payable to members serving in Britain, Canada, Hong Kong, Indonesia, Japan, Malaysia, Singapore, Switzerland, Thailand or the United States of America; and
- c. by decreasing, with effect from the date on which the attached determination is signed, one rate of Supplementary Living Allowance payable to members serving in Singapore.

Clauses 6 and 12 of this determination amend Determination 3718:

- a. by increasing, with effect from 12 June 1986, some of the rent ceilings applicable to members serving with the United Nations in Israel; and
- b. by decreasing, with effect from 21 August 1986, the rent ceilings applicable to members serving with the United Nations in Syria.

Clauses 7 and 13 of this determination amend Determination 3724:

- a. by introducing, with effect from 12 June 1986, rates of Child Allowance for members serving in Italy;
- b. by increasing, with effect from 12 June 1986, the rates of Child Allowance payable to members serving in Britain, Canada, China, Hong Kong, Indonesia, Israel, Japan, Malaysia, Singapore, Switzerland, Thailand or the United States of America; and
- c. by decreasing, with effect from 21 August 1986, the rates of Child Allowance payable to members serving in Syria.
