**Application**

2. Paragraphs 1 (a), 1 (b), 1 (c) and 1 (e) of this Determination shall apply in relation to service by a member on or after 1 June 1986.

3. Paragraph 1 (d) of this Determination shall apply in relation to service by a member on or after 29 May 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 55 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3718, Overseas Rental and Utilities Allowance, provides for payment of an allowance to members of the Defence Force serving overseas for longer than 6 months to meet the additional cost of living at an appropriate standard in residential accommodation.

Paragraphs 1(a), 1(c) and clause 2 of this determination amend Determination 3718 to increase, with effect from 1 June 1986, the rent ceilings upon which the rates of the allowance are based for members serving on duty in Hong Kong or Japan.

Paragraphs 1(b), 1(e) and clause 2 of this determination amend Determination 3718, with effect from 1 June 1986, by omitting clause 49, which allows the increase of rent ceilings in Hong Kong by an approving authority, and by replacing it with a more beneficial provision included in clause 77 of Determination 3718 allowing the approving authority to increase the rent ceilings by a larger amount in certain circumstances.

Paragraph 1(d) and clause 3 of this determination amend Determination 3718 to increase, with effect from 29 May 1986, the rent ceilings upon which the rates of the allowance are based for members serving on duty in the Philippines.
