EXPLANATORY STATEMENT

DETERMINATION NO. 56 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3601, Travelling Allowance, Determination 3610, In Port Allowance, Determination 3711, Settling In and Settling Out Allowance and Determination 3731, Meal Allowance Overseas, provide for payment of allowances which reimburse the additional travelling costs incurred by members of the Defence Force serving on duty overseas.

Clauses 1, 2 and 6 of this determination amend Determination 3601, Travelling Allowance, in its application to members serving in France:

- a. by increasing certain rates with effect from 2 July 1986; and
- b. by decreasing other rates with effect from 4 September 1986.

Clauses 3 and 7 of this determination amend Determination 3610, In Port Allowance, by increasing, with effect from 2 July 1986, the rates payable to members serving in France.

Clauses 4 and 8 of this determination amend Determination 3711, Settling In and Settling Out Allowance, in its application to members serving in France:

- a. by increasing certain rates with effect from 2 July 1986; and

- b. by decreasing other rates with effect from 4 September 1986.

Clauses 5 and 9 of this determination amend Determination 3731, Meal Allowance Overseas, by increasing, with effect from 2 July 1986, the rates payable to members serving in France.
