EXPLANATORY STATEMENT

DETERMINATION NO. 59 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3601, 3610, 3711 and 3731 provide respectively for the payment of:

- a. Travelling Allowance;
- b. In Port Allowance;
- c. Settling In and Settling Out Allowance; and
- d. Meal Allowance Overseas,

to members of the Defence Force serving overseas to reimburse the travelling costs incurred or to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs involved because of that service overseas.

This determination amends the rates of these allowances which are payable to members serving in the countries mentioned in the following paragraphs.

Clauses 1, 2 and 6 of this determination amend Determination 3601, Travelling Allowance:

- a. by increasing, with effect from 12 May 1986, the rates in Belgium;
- b. by introducing, with effect from 11 June 1986, new rates of this allowance for members in Germany who reside in accommodation where breakfast is included in the cost of accommodation;
- c. by introducing, with effect from 11 June 1986, a C rate of this allowance for members in Switzerland who reside in hotel accommodation; and

- d. by increasing, with effect from 11 June 1986, the existing rates in Germany and Switzerland.

Clauses 3 and 7 of this determination amend Determination 3610, In Port Allowance:

- a. by increasing, with effect from 12 May 1986, the rates in Belgium; and
- b. by increasing, with effect from 11 June 1986, the rates in Germany.

Clauses 4 and 8 of this determination amend Determination 3711, Settling In and Settling Out Allowance:

- a. by increasing, with effect from 12 May 1986, the rates in Belgium; and
- b. by increasing, with effect from 11 June 1986, the rates in Germany and Switzerland.

Clauses 5 and 9 of this determination amend Determination 3731, Meal Allowance Overseas:

- a. by increasing, with effect from 12 May 1986, the rates in Belgium; and
- b. by increasing, with effect from 11 June 1986, the rates in Germany and Switzerland.
