Determination under Section 58B of the Defence Act 1903' (Amendment)

Child Allowance

1. Determination 3724, Child Allowance, is amended—

- (a) by omitting from clause 6A, "7B";
- (b) by omitting clause 7B;
- (c) by omitting from clauses 11, 13 and 14 "7B,"; and
- (d) by omitting from clause 15 "7B," (wherever occurring).

Education Assistance Overseas

2. Determination 3725, Education Assistance Overseas, is amended—

- (a) by omitting from clause 6 "Subject to clause 6A, an" and substituting "An"; and
- (b) by omitting clause 6A.

Child Education Allowance

3. Determination 3726, Child Education Allowance, is amended—

- (a) by inserting “or” at the end of sub-paragraph 4 (d) (ii);
- (b) by omitting paragraph 4 (dd);
- (c) by omitting from paragraph 4 (e) “or (dd)”;
- (d) by omitting paragraph 5 (a) and substituting the following paragraph:
 “(a) where the child boards and resides at the school at which he or she is undertaking a course of education—an amount equal to the sum of the amount for boarding ascertained in accordance with paragraph 6 (a) and the amount for tuition ascertained in accordance with clause 7; and”; and
- (e) by omitting clause 7A.

Application

4. This Determination shall apply from and including 13 October 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 60 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determinations 3724, 3725 and 3726 provide respectively for the payment of Child Allowance, Education Assistance Overseas, and Child Education Allowance to members of the Defence Force who are serving overseas to enable them to meet the additional costs incurred in maintaining and educating their children as a result of that overseas posting.

Clauses 1, 2 and 3 of this determination amend Determinations 3724, 3725 and 3726, respectively, to cease application of provisions which, concurrently, entitled the Team Leader of the New Construction Submarine Combat System to payment of special rates of Child Allowance and Child Education Allowance and disentitled the member to payment of Education Assistance Overseas.

Clause 4 of this determination applies these changes with effect from 13 October 1986.
