## Determination under Section 58B of the Defence Act 1903<sup>1</sup> (Amendment)

### Overseas Rental and Utilities Allowance

1. Determination 3718, Overseas Rental and Utilities Allowance, is amended—

(a) by inserting after Division 10 of Part III, the following Division:

#### *“Division 10A—Italy*

“51A. The monthly rent ceiling applicable to a member who is serving on duty in Italy and who leases furnished accommodation is the amount specified in the following table in relation to the members accommodation group:

(b) by inserting after the entry relating to Indonesia in the table in clause 77 the following entry:

“Italy . . . . . 20 20”; and

(c) by inserting after clause 86 the following clause:

"86A. For the purposes specified in paragraph (a) of 'A' in the formula in clause 22, where a member who is serving on duty in Italy incurs separate costs for garage rental or, where the member is serving on duty in Rome and incurs condominium charges, the rent paid by the member for his or her accommodation shall be deemed to be an amount calculated in accordance with the formula—

$$A + B + C$$

where—

A is the actual rent paid by the member for his or her accommodation;

B is the amount, if any, incurred by the member for garage rental; and

C is, in respect of a member serving on duty in Rome, the amount, if any, incurred by the member for condominium charges."

**Education Assistance Overseas**

2. Determination 3725, Education Assistance Overseas, is amended—

(a) by inserting after paragraph 10 (f) the following paragraph:

"(fa) Italy;"

(b) by inserting after Division 7 of Part III, the following Division:

***"Division 7A—Italy***

"23B. Where a member to whom clause 6 refers is serving on duty in Italy and incurs costs in transporting a child to or from school by school bus, other than the compulsory transport costs referred to in paragraph 7 (i), those costs shall be deemed to be an education expense for the purpose of clause 7 and clause 10 shall not apply to the member in respect of that transport."

(c) by inserting the following entry in Part 1 of the Schedule after the entry relating to Indonesia:

"Italy . . . . . The Overseas School in Rome";

(d) by inserting the following entry in Part 2 of the Schedule after the entry relating to Indonesia:

"Italy . . . . . The Overseas School and St George's English School in Rome"; and

(e) by inserting the following entry in Part 3 of the Schedule after the entry relating to Indonesia:

"Italy . . . . . The Overseas School and St George's English School in Rome".

**Complementary Allowances Payable to Member Serving on Duty Overseas**

3. Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, is amended by inserting after Division 10 of Part II, the following Division:

***“Division 10A—Member Serving on Duty in Italy***

**Definition**

“85A. In this Division ‘member’ means a member who is serving in Italy.

**Household Assistance Allowance**

“85B. Where a member—

- (a) is in allowance group 4, 5, 6 or 8;
- (b) is entitled to Representation Allowance and his or her representational duties involve regular home entertainment; and
- (c) employs a person or persons, for the purposes of household assistance and expends an amount per annum for wages, bonuses, social security payments and severance pay in respect of employing that person or those persons in excess of the amount, in relation to his or her allowance group, specified in the following table,

the member shall be paid a Household Assistance Allowance of an annual amount equal to the lesser of—

- (d) that excess amount; or
- (e) Lire 2,847,000.

**Application**

4. This Determination shall apply in relation to service by a member from and including 1 August 1986.

EXPLANATORY STATEMENT

DETERMINATION NO. 62 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3718, Overseas Rental and Utilities Allowance, provides for payment of an allowance to members of the Defence Force serving overseas for longer than 6 months to meet the additional cost of living at an appropriate standard in residential accommodation overseas.

Clauses 1 and 4 of this determination amend Determination 3718 to introduce, with effect from 1 August 1986, rent ceiling provisions for the purposes of calculating the amount of Overseas Rental and Utilities Allowance payable to members serving in Italy.

Determination 3725, Education Assistance Overseas, provides for payment of financial assistance to a member of the Defence Force who is posted overseas on long term duty and incurs certain costs in educating a child overseas.

Clauses 2 and 4 of this determination amend Determination 3725 by introducing, with effect from 1 August 1986, provisions relating to assistance with the cost of school transport for the children of members posted to Italy and also to introduce approved schools for Italy for the purposes of payment of this allowance.

Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, provides for the payment of a range of allowances to compensate for living costs incurred by a member of the Defence Force while serving in an overseas country.

Clauses 3 and 4 of this determination amend Determination 3901 to introduce, with effect from 1 August 1986, a Household Assistance Allowance for members serving on duty in Italy.
