Overseas Rental and Utilities Allowance

1. Determination 3718, Overseas Rental and Utilities Allowance, is amended—

- (a) by omitting from clause 65 "Subject to clause 66, the" and substituting "The"; and
- (b) by omitting clause 66.

Complementary Allowances Payable to Member Serving on Duty Overseas

2. Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, is amended by omitting the table from clause 107C and substituting the following table:

Less than 750	2,950
750 or more	4,720

3. Clause 2 of this Determination shall apply in relation to service by a member from and including 12 September 1985.

EXPLANATORY STATEMENT

DETERMINATION NO. 63 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3718, Overseas Rental and Utilities Allowance, provides for payment of an allowance to members of the Defence Force serving overseas for longer than 6 months to meet the additional cost of living at an appropriate standard in residential accommodation overseas.

Clause 1 of this determination amends Determination 3718, with effect from the date this determination is signed, by deleting clause 66, which permitted an approving authority to increase the rent ceiling applicable to a member serving on duty in Thailand. An approving authority may increase the rent ceiling of such a member under the provisions of clause 77 of Determination 3718.

Determination 3901, Complementary Allowances Payable to Member Serving on Duty Overseas, provides for the payment of a range of allowances to compensate for living costs incurred by members of the Defence Force while serving in an overseas country.

Clauses 2 and 3 of this determination amend Determination 3901, with effect from 12 September 1985, by increasing the rates of Gardening Assistance Allowance payable to members serving on duty in the Netherlands.
