EXPLANATORY STATEMENT

DETERMINATION NO. 65 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 3601, Travelling Allowance, Determination 3610, In Port Allowance, Determination 3711, Settling In and Settling Out Allowance and Determination 3731, Meal Allowance Overseas, provide for payment of allowances which reimburse the additional travelling costs incurred by members of the Defence Force serving on duty overseas.

Clauses 1, 2 and 6 of this determination amend Determination 3601, Travelling Allowance, payable to members serving overseas:

- a. by introducing, with effect from 10 July 1986, new rates for members proceeding on short term duty within Austria, Denmark and Finland;
- b. by introducing, with effect from 10 July 1986, a new B rate of this allowance for members serving on short term duty in Finland;
- c. by increasing, with effect from 10 July 1986, other rates in Austria, Denmark and Finland;
- d. by increasing, with effect from 16 July 1986, certain rates in the United States of America;
- e. by introducing, with effect from 24 July 1986, certain new rates in Colombo, Sri Lanka;
- f. by introducing, with effect from 1 August 1986, the rates for members proceeding on short term duty within Mexico;

- g. by introducing, with effect from 1 August 1986, a new B rate of this allowance for members serving on short term duty in Mexico;
- h. by increasing, with effect from 1 August 1986, other rates in Mexico;
- i. by increasing, with effect from 30 August 1986, the rates in Jordan; and
- j. by decreasing, with effect from 2 October 1986, the rates in Laos.

Clauses 3 and 7 of this determination amend Determination 3610, In Port Allowance, payable to members serving overseas:

- a. by introducing, with effect from 10 July 1986, new rates for Denmark and Finland;
- b. by increasing, with effect from 16 July 1986, the rates for the United States of America;
- c. by introducing, with effect from 1 August 1986, new rates for Mexico; and
- d. by introducing, with effect from 30 August 1986, new rates for Jordan.

Clauses 4 and 8 of this determination amend Determination 3711, Settling In and Settling Out Allowance, payable to members serving overseas:

- a. by introducing, with effect from 10 July 1986, new rates for Denmark;
- b. by increasing, with effect from 16 July 1986, certain rates in the United States of America; and
- c. by introducing, with effect from 1 August 1986, new rates for Mexico.

Clauses 5 and 9 of this determination amend Determination 3731, Meal Allowance Overseas, payable to members serving overseas:

- a. by introducing, with effect from 10 July 1986, new rates for Austria, Denmark and Finland;
- b. by introducing, with effect from 1 August 1986, new rates for Mexico;
- c. by introducing, with effect from 30 August 1986, new rates for Jordan; and
- d. by decreasing, with effect from 2 October 1986, certain rates in the United States of America.
