EXPLANATORY STATEMENT

DETERMINATION NO. 66 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

The following determinations provide for the payment of allowances to members of the Defence Force who are serving overseas to enable them to maintain a standard of living comparable to their standard in Australia by reimbursing the additional costs incurred because of that service overseas:

- a. Determination 3713, Intermediate Term Duty Living Allowance;
- b. Determination 3714, Overseas Living Out Allowance;
- c. Determination 3715, Overseas Living In Allowance;
- d. Determination 3716, Supplementary Living Allowance;
- e. Determination 3724, Child Allowance.

Clauses 1 and 7 of this determination amend Determination 3713 by increasing, with effect from 10 July 1986, the rates payable to members serving in Canada or the United States of America.

Clauses 2, 3 and 8 of this determination amend Determination 3714 by:

- a. increasing, with effect from 10 July 1986, the rates in Canada, France, Germany, India, Italy, Japan, the Netherlands, Pakistan, Singapore, the Solomon Islands, Sweden, Switzerland and the United States of America;
- b. increasing, with effect from 24 July 1986, some of the rates in China; and

- c. decreasing, with effect from 2 October, other rates in China.

Clauses 4 and 9 of this determination amend Determination 3715 by increasing, with effect from 10 July 1986, the rates payable to members serving in Canada, Germany or the United States of America.

Clauses 5 and 10 of this determination amend Determination 3716 by increasing, with effect from 10 July 1986, the rates payable to members serving in Canada, France, Germany, India, Italy, Japan, the Netherlands, Pakistan, Sweden and Switzerland and some of the rates in Singapore, the Solomon Islands or the United States of America. One rate, which is payable to members serving in Singapore, is being increased from 21 August 1986.

Clauses 6 and 11 of this determination amend Determination 3724 by:

- a. increasing, with effect from 10 July 1986, the rates in Canada, France, Germany, India, Italy, Japan, the Netherlands, Pakistan, Singapore, the Solomon Islands, Sweden, Switzerland and the United States of America; and
- b. increasing, with effect from 24 July 1986, one of the rates in China.
