Outfit Allowance For Special Appointments

Determination 0606, Outfit Allowance For Special Appointments, is amended—

- (a) by inserting after "articles of clothing or necessaries" in clause 4 "or, where it is practicable and it is expected to be cheaper over the period during which the member is serving in the position, the hire of that article or those articles of clothing or necessaries in lieu of their purchase";
- (b) by inserting after "him" in paragraph 4 (a) "or her";
- (c) by inserting after "he" in paragraph 4 (b) "or she";
- (d) by inserting after "his" in paragraph 4 (b) "or her";
- (e) by inserting after "approving the purchase" in clause 6 "or the hire";
- (f) by inserting after "him" in paragraph 6 (b) "or her";
- (g) by inserting after "he" in paragraph 6 (b) "or she";

- (h) by adding at the end of paragraph 6 (d) “, or the cost which the member is likely to incur in hiring those articles of clothing or necessaries from time to time during the period of his or her service in the position”; and
 - (i) by adding at the end of paragraph 6 (e) “or clause 4”.

EXPLANATORY STATEMENT

DETERMINATION NO. 7 OF 1986

ISSUED BY THE AUTHORITY OF THE MINISTER FOR DEFENCE

UNDER SECTION 58B OF THE DEFENCE ACT 1903

Section 58B of the Defence Act 1903 allows the Minister to make determinations on conditions of service for members of the Defence Force.

Determination 0606, Outfit Allowance For Special Appointments, provides for the payment of a clothing and equipment allowance to members of the Defence Force appointed as Aides-de-Camp to the Governor-General, or for other special appointments as aides or equerrys.

This determination amends Determination 0606 to permit reimbursement of hiring charges as an alternative to purchase costs where it is expected to be cheaper, and to make minor textual amendments.

The date of effect is the date on which this determination is made.
